PUBLIC & PRIVATE PARTNERSHIPS:

Community Cares Partners

Two heads are better than one. Teamwork makes the dream work. There are many phrases in the English language that make the same point—collaboration and partnerships create more impact than going it alone. This is the very idea behind the concept of public/private partnerships. Born out of the necessity for increased efficiency, these partnerships occur when a combination of public and private sector entities join together for a common project. This idea of cross-collaborating and joining forces resonates deeply with the mission of Communities Foundation of Oklahoma.

In response to the COVID-19 pandemic and resulting community shut-down, CFO gathered together like-minded friends and peers and began discussing how philanthropy could identify and address the resulting needs on those in our community, specifically to address housing, food, utilities and other essentials. These discussions coincided with the passage of the Federal CARES Act in March, 2020. Almost immediately, CFO and several private funders began collaborating on how coordinating with government entities could bring faster and more efficient relief for those in desperate need. CFO reached out to leaders of the city, county and state and discussed the concept of creating a temporary, "one-stop" source for residents to access the CARES support available by establishing Community CARES Partners (CCP), a program of CFO.

Through this public/private partnership, CCP was given initial donations from private philanthropists totaling \$435,000 which not only helped cover the initial administrative costs, but also allowed CCP to start distributing rent relief one (1) week before the government funds were available. Because the process of cross-collaboration was so effective, CFO and its program partners were awarded the contract for the two additional government funded relief programs that will run through 2025. With CFO acting as the program administrator, we were able to coordinate resources from like-minded community partners and create a program that was reliable, efficient and worked to change lives in the midst of a once-in-a-century pandemic.

SCHOLARSHIPS: The Evolution to Efficiency

During the long history of CFO, the scholarship program has produced a rich tradition of success through the thousands of students served. Although the program has grown for many years, the evolution to efficiency began two years ago when a reexamination of the relationships we had with our students occurred. Knowing changes needed to be made, Director of Scholarships, Austin Klososky, focused on enhancing communications between CFO, our donors and students. Scholarships tend to be deeply personal not only to the donor, but to the recipient as well. With this in mind, CFO wanted to acknowledge and celebrate the tremendous accomplishments achieved through the generosity of donors and award of scholarships.

The first major step taken was creating a Universal Application to house all scholarships. By doing so, students were able to see quickly, and with one initial application, the numerous scholarships they initially qualify for. Prior to this, students had to individually apply for each scholarship resulting in students missing opportunities for which they were eligible. Austin then focused his attention and efforts on more personal communication with our students and donors. He added a texting service to reach students in a more direct way and sent letters in addition to personalized emails; we created a new section on the website for students to easily view deadlines. These changes resulted in a more efficient and transparent relationship.

These measures would mean nothing if they didn't create an environment in which we were able to strategically plan, alongside our donors, for a more vibrant and transformational scholarship program. While expansion to serve more students is always a goal, partnering with individuals and organizations whose missions align with ours is our focus. This year, in the midst of a once in a century pandemic, it has been our privilege to work with the Lynn Health Science Institute as they look to expand their scholarship giving to benefit not only their employees but their employee's children, as well. As an organization, they are dreaming beyond today, ensuring the next generation is afforded educational opportunities.

Scholarships have always been a backbone of CFO—they allow donors to see the impact of their generosity in real time. Though the program has evolved over the past few years, its core mission of direct-impact giving has never wavered. The way education is delivered has shifted the past year and will remain fluid for the upcoming future; scholarships will continue to be the steadying force that ensure students attain an education they deserve.

ENDOWMENTS:Consistency Amidst Change

In times of difficulty or change, our nature is to seek out anything stable. To anything that will allow us to feel a sense of normalcy and keep living our lives. In the times of philanthropy during COVID, that stability came in the form of Endowment Funds. While many nonprofits experienced reduced donations,

Endowment Funds provided organizations across the state with the stable funding they needed to continue serving during tough times.

Like the stability of the funds, our commitment to endowments is unwavering. To ensure our donors understand the importance we place on these funds, we match every endowment dollar donated with a 5% donation from CFO. This pledge, along with our investment strategies, allows us to work with individuals and organizations to make sure that the growth of the funds is reflective of the passion behind the organization's mission.

Although the case for Endowment Funds had always been present, nothing highlighted this need more than the shutdowns and social distancing that came with COVID-19. Nonprofits and organizations designed to serve their communities exist off interpersonal connections; take that away and it becomes harder and harder to serve their true purpose. Through these trying times we saw nonprofits turn on a dime and rework their entire model to continue service to their communities. Although the work went on, sometimes the fundraising could not—it was in these situations that organizations with an Endowment Fund were able to stay afloat, plan for the future and continue their work. The stability created by these funds is why they exist; they had always been needed but like many other characteristics of COVID-19, it took the world shifting to understand the true importance that stability plays in our society.

GRANTS: Meeting Needs

Donors give for a multitude of reasons, each unique to that person or family. Some might involve a personal financial decision; others might want to impact a cause close to their hearts. Regardless of the motivation, the resulting impact of grants is clear. At Communities Foundation of Oklahoma, we are proud to house grant making programs that have stepped up to the plate in the last year and pivoted to meet the needs of communities during crisis.

As an organization, we were pleased this last year to reinitiate the Oklahoma Initiative Fund—a longstanding tradition at CFO. Through this state-wide grantmaking fund, our focus is the same as the mission that drives us—serving Oklahomans and meeting the needs they set forth. Because of collaborative conversations, three issue areas were identified: strengthening rural libraries, food security and healthcare. Through completion, \$115,000 was distributed to 12 different organizations across the state.

In addition, the grant-making work of our partner funds has been critical throughout the last year. At Women's Foundation of Oklahoma, the Board decided to act quickly when COVID arose and pivoted their program to ensure emergency grants were given to past recipients for pandemic-related needs for single mothers. Grants are intended to do just that—meet people where the needs lie. Our other partner, Oklahoma Educational Technology Trust, knows all about that kind of service. For the past 20 years they have been making life-changing grants to schools in need across the state. Technology inequity is one of the greatest access barriers of the current time and COVID only highlighted this gap. OETT and their partners at the K20 Center work every day to ensure that students have equitable access to the current technology and teachers have the training to assist them along the way.

Grants are one of the things that immediately come to mind when thinking about philanthropy—and with good reason; they are impactful and create change in our communities. At CFO, through collaboration and partnerships with other organizations, we are excited and energized for what the future holds.
